
#### **SEMINAR INSTRUCTORS**

He has presented and trained on legal-based standards, policy and procedure development, creating constitutionally safe jails and prisons, PREA, and auditing and inspection programs at numerous conferences, state sheriff association meetings, state jail administration seminars and other training venues for correctional staff and administrators. He also serves as the Executive Director for Accreditation, Audit & Risk Management Security (AARMS) and Chief Editor of the National Institute for Jail Operations website.



**Blake Hamilton, esq** has significant trial experience in both Federal and State Courts.
